APPLICATION RANGE:

For daily use on all acid-proof surfaces in sanitary, bath and swimming pool areas e.g. on tiles, glass, plastic, chromium and stainless steel. Do not use on surfaces that are sensitive to acids. In order to remove persistent lime deposits, we recommend the use of our Spontan Super.

INSTRUCTIONS FOR USE AND DOSAGE:

Manual: Pre-wet surfaces. Apply at certain points with a non-abrasive sponge and Edit surfaces. For light soiling, add 20-50 ml of product to 8 L of cold water (0.25-0.625 %).

Product residues after cleaning the treated surfaces. Rinse with plenty of clean water.

Usage in automatic machines:

According to the specifications of the manufacturer of the machine or at a dilution level of up to 1%. In the case of heavy discolorations, pre-process the area. The efficiency of the cleaning can be improved sharply by the use of coordinated scrub pads.

Rinse off product left behind after cleaning the treated surfaces with lots of clean water. Using the right quantities saves cost and protects the environment. Store away from the reach of children. Do not mix the product with other cleaning agents. Please check the compatibility of the product with the material to be cleaned at an inconspicuous place on the material to be cleaned. No liability shall be accepted for unintended use and for the damage that may result from this.
