INSTRUCTIONS FOR USE AND DOSAGE:

Simply add Prodil to main wash cycle jointly with detergent. Depending on degree of soiling add between 10-20 g/kg dry laundry. Strongly soiled laundry should be presoaked prior to machine wash - in Prodil enriched water - or add Prodil into the pre-wash cycle! Conduct a material compatibility test on a small area of the coloured laundry before starting.

Always follow the cleaning instructions of the manufactorer.
